THE ILLINOIS LAW LLM PROGRAM

The core of the LLM program is the fundamentals of US Law, with courses specifically designed for professionals and students educated outside the United States. Core courses include Contracts and Civil Procedure, Legal Writing and Research, and Professional Responsibility.

Beyond the core courses, LLM students select from the nearly 200 classes offered each year, allowing them to further develop expertise within their own specialized fields or interests. These courses are taken alongside the JD students, a hallmark of the Illinois program.

LLM students are also provided individualized counseling and have the opportunity to participate in practical training, including competitions and trial advocacy.

TECHNOLOGY AND THE LAW

The University of Illinois at Urbana-Champaign is an epicenter of innovation and discovery. In this fertile environment, the curriculum and faculty at Illinois Law cover a deep and broad spectrum of intellectual property and technology law, including in the areas of trademark, internet, patent, copyright, supercomputing, biotechnology, information science, and engineering. Campus, state, and national leaders solicit the faculty's legal expertise on IP issues arising from a host of new technologies, and organizations such as Google, Microsoft, and Department of Homeland Security currently fund research at Illinois Law.

Application requirements include:

- Completed application, using the LSAC LL.M. application or the University of Illinois Graduate College application
- Résumé
- Statement of purpose
- Certified transcripts and credentials
- Declaration of finances and supporting documentation
- Two letters of reference
- TOEFL or IELTS score reported from ETS or IELTS
- Copy of passport page
